Call to Order. Chair Dr. Harry Lieberman opened the meeting at 8:35am.

Public Comments. Sue Kaplan NW Block Captain for Neighborhood Watch and CERT reviewed 2015/2016 accomplishments, goals and calendar with handouts. In addition, Ms. Kaplan outlined 2015/2016 CERT training calendar and statistics with handout. It was agreed that for both programs to be successful opportunities to exercise skills need to occur. Sue Kaplan advised that Councilperson Luis Reinoso will assume her responsibilities.

Chief Rueda Liaison Report. Chief Rueda suggested CERT would be an additional resource for certain city events. He indicated CERT assistance would be helpful with weather related incidents, red flag warnings and assist at public events such as Open House with Chief Miller's approval. Chief Rueda also indicated that Pulsepoint, a free mobile app that alerts a trained volunteer in CPR, will be available in the Verdugo system in July, 2016.

Chief Miller Liaison Report. Chief Miller advised that Corporal Shannon Robledo will be promoted to Sergeant on March 15<sup>th</sup> at 1100 in Council Chambers, updated police officer recruitment status and the annual Block Captain meeting will be on April 27, 2016. Additionally he discussed the high school girl self- defense classes, citizen's academy, the March 12<sup>th</sup> strategy meeting and the 2015 Annual Report.
