*Directions from Mission Street and Fremont Avenue in South Pasadena: Travel on Mission Street going west, going through intersections at Orange Grove Avenue and Grand Avenue. Stay in the right lane (left lane curves to the left and turns into Pasadena Avenue) and travel downhill a short distance to a stop sign at Arroyo Drive. The entrance to the Arroyo Seco Park is almost directly across the intersection on Stoney Drive (note a small red and blue sign for the Golf Course on the left corner). Enter Stoney Drive and travel along a curving, downhill road. Take the next left onto Lohman Lane. Pass the Arroyo Seco Racquet Club on the right and park adjacent to the Golf Course buildings on the left.
